Dear Parent or Carer,

As you may already know there is an expectation that students will be back in school full time in September. We are excited to be welcoming back every member of the Heron Hall family but as I am sure you appreciate these are unprecedented times and it will mean that there will be a number of changes to how the school and the school day will operate. We also understand that many of you may be apprehensive about sending your child back to school and we hope that this letter will support you in knowing that we are doing everything we can to ensure that it is safe to do so.

Return to School Date in September

We will be returning to school in a staggered manner across the week beginning 7th September. Please pay close attention to the dates that students are expected back in school on the table below. Any absence from that date forwards will be marked as an unauthorised absence unless prearranged with the school.

Arrival and Exit Times from School

As you will understand the arrival and exit from the school are two of the points where there is the potential for the largest number of students to come into contact with each other. We have therefore decided to stagger the entry and exit from the school. This will mean that we will use both entrances and exits and students will be staggered in their arrival and leaving times. We need to stress that <u>the</u> <u>school gates will be locked until 8:15am</u> and students will not be allowed in before this time. Students need to aim to arrive <u>5 minutes before</u> their Period 1 start time.

We also need to remind parents that Queensway has limited parking and there is not access to Belling Crescent and Ediswan way for parents at Heron Hall. We recommend that parents who wish to park and wait for students use the Tesco Car Park to do so. The entry and exit times for students can be found below:

Hand Sanitising

Students will be expected to sanitise their hands upon entry to the building and will also be provided with space to sanitise their hands outside of classrooms on a regular basis.

Student Rooming Within the Building

Students across the year groups will be placed in separate part of the building to ensure that we can operate year group bubbles. No other student from other year groups will be able to access these areas and each part of the school will have dedicated toilets for that year group. By isolating each year group separately and ensure minimal contact we are able to open the school to all year groups each day.

It is important that students adhere to these rules of not coming in to contact with students in other bubbles during the school day. We have been advised by the government that if one student in a year group has a confirmed case of Covid-19 this will result in the entire bubble, potentially the entire year group, having to go into lock down for 14 days. This is something we want to avoid and therefore any student caught not following these health and safety rules will be dealt with through the behaviour policy.

Lessons from September

Students in Year 7 and 8 will undertake all of their lessons in form groups. This allows us to limit the size of their bubbles to a maximum of 30 students. They will be taught all of the subjects in the curriculum but some of these subjects will need to be theoretical (e.g. music/art/drama) rather than practical for the first few weeks of term.

Students in Year 9 -11 will study their option subjects within their allocated areas of the school. Students in Year 10 will have access to facilities in the vast majority of their subjects with students in Year 11 having access to all of the science and technology facilities that they will need to support them with their exams.

PE Kit and Uniform

Due to restrictions around changing rooms and facilities it will not be possible for all students to use the changing facilities before PE. In order to ensure that students still have access to PE while we are following these new procedures students can wear PE Kit on the days that they have PE. On all other days students must follow normal uniform rules and wear the correct school uniform including shoes. Please be advised that this is a temporary measure and if behaviour deteriorates it will be removed.

Social Times & Canteen Access

All of the students at Heron Hall will be provided access to their full lunch time facilities. Lunch times will be staggered with some students eating earlier or later than others in order to ensure that all students have time to eat. When a year group is in the canteen/main hall it all students from that year group will be with them even if they are not eating. Students can still bring a packed lunch rather than buying food at school and all students on Free School Meals will continue to receive these

In order to minimise queuing and therefore avoid contact between students we will be closing the canteen facilities at break time. Therefore, students will not be able to purchase food at break and **will only be able to purchase food at lunch time**.
