Covid-19 testing in the school

As we start planning to fully reopen Heron Hall Academy, you will probably now be familiar with the governments statement about testing for Covid-19 in schools to minimise cases and restrict the transmission of the virus.

Up to a third of individuals who test positive for the coronavirus have no symptoms at all and can therefore spread it unknowingly. That is why the government says that testing of students and staff without symptoms is vital. Identifying those individuals will save lives.

Testing for pupils

Testing in school will be undertaken by our staff and volunteers, all of whom will undergo the compulsory training provided by the government.

Routine testing

Our school-will be using the 'Lateral Flow Test'. Under guidance, students will self-administer the test themselves. This is a nose and throat swab and processing of these tests will be conducted at a dedicated testing site in the school with results available in around 30 minutes. A second test is then carried out three days later.

NHS Guidance will be available in the school and at the dedicated testing sites. The guidance is also available at the following web link: -

If the lateral flow test result is negative, the parent will not be contacted.

If the lateral flow test results indicate the presence of COVID-19, pupils will be informed and parents notified. The pupil will need to self-isolate for a period of 10 days in line with government guidance.

We will notify anyone who has been in close contact with someone who has tested positive as they will also need to self-isolate. We will not provide the names of individuals who have tested positive to other parents / pupils.
