Centre Assessment Policy

Please find attached our Centre Assessment Policy which outlines how grades will be awarded. Please take time to read this carefully. This policy will be ratified by the Joint Council for Qualifications, and will form the basis of any enquiry or future appeal concerning grades awarded.

Mitigating Circumstances

After all Final Assessments are complete, students will be informed of the specific evidence that will be used in each subject to calculate an overall grade. At this point, they will have the opportunity to inform us of any 'mitigating circumstances' that have affected them during the time of those assessments.

A mitigating circumstance is something that has directly impacted an individual during one of the assessments being used as evidence for an overall grade. Lockdown will not qualify as a mitigating circumstance, as all students were affected and national exams were replaced by school-set assessments as schools knew which parts of the curriculum were/weren't covered.

Mitigating circumstances will need to be supported by evidence. Where there are genuine circumstances that have affected a student, then teachers will make every effort to use alternative evidence (e.g. they may be asked to sit a different assessment).

A form will be available to inform us of any mitigating circumstances from Monday 24th May. The deadline for informing us of any mitigating circumstance is Friday 28th May.

Please be aware that a failure to inform us of any mitigating circumstance will invalidate a future appeal on that basis.

Quality Assurance

In order to ensure fairness in marking assessments and awarding grades, all students' work will continue to be 'blind marked' (teachers will not know the name of the student whose work they are marking). In addition, moderation will take place within departments and with other schools to ensure marking is accurate. Exam Boards will request samples of marked work in order to further ensure fairness and accuracy.

Results & Appeals

COVID rules permitting, students will collect their grades on Thursday 12th August. More information will follow on this. Students will have the right to appeal their grade if:

 They believe the Academy has made an administrative error (e.g. they have been awarded another student's mark)



• They believe we have not followed the policies and procedures set out in our Centre Assessment Policy Please be aware that simply disagreeing with a mark or grade awarded will not constitute grounds for appeal. A more detailed explanation of the Appeals Process will be published in due course.

We will continue to keep parents and students informed of any further updates as appropriate. Finally, I would like to reassure you once again that all of our teachers are undertaking this process with the utmost integrity and professionalism. We recognise that this is a potentially anxious time for students but it is important to remember that students have complete agency over this process. Their grades will be based on their attainment in their assessments. If you have any queries, please do not hesitate to contact me.
